Rwanda

The Organization opened its first purpose-built facility in Rwanda in 2022, a state of the art research and education center aimed at accelerating the critical science and training needed for effective conservation. It serves as an educational hub, hosting more than 50,000 visitors, including 10,000 school children, in its first two years. The Fossey Fund maintains its daily protection activities for roughly half of the gorilla families in Rwanda, removing 1,000 illegal snares this year, and continues to expand its research program on both gorillas and the surrounding biodiversity. Community development programs focused on food security and livelihood initiatives, including

Democratic Republic of the Congo

The Fossey Fund protects critically endangered Grauer's gorillas through managing a community conservation forest called Nkuba. In 2022, the Fossey Fund announced a 50% increase in Nkuba to more than 600,000 acres of primary forest, which includes at least 9 globally threatened large mammals, including Grauer's gorillas and eastern chimpanzees. Hunting remains a significant threat to wildlife, as shown by the more than 2,000 snares that were removed by Fossey Fund staff. To help lessen the communities' dependence on the forest for food and income, the Organization focuses on food security and livelihood initiatives, including fish farming, vegetable gardens, honey production and sewing
